

# Minutes of the June Meeting of the United Neighborhood Coalition

Speakers from the Department of Transportation described a cross-town transport study being launched by DC Department of Transportation (DDOT) this late summer/early fall.

The study will involve an East-West corridor to better connect the McMillan Development and Armed Forces Retirement Home to areas to the West. The study is still in the process of contracting a team that will conduct an intersection-by-intersection analysis of the corridor, which will cover the area from Randolph/Shepard streets down to Howard.

Neighbors asked if the study would just address East-West traffic, or also address North-South traffic, particularly along Park Place, making it more friendly for bicycles. Another neighbor asked whether the study would include attention to tree boxes and wider sidewalks in Park View, or if this was beyond the scope of the study. It was not clear whether the East-West corridor study would address these concerns.

Speakers also described the Great Streets program, which provided \$8 million in funding for improvements to small businesses (for example, façade improvements, heavy equipment). Half of which is reserved for developments along H street. Grants can be up to \$84 thousand dollars.

Reginald Arno from the Street & Bridge Maintenance program described the process DDOT uses to respond to maintenance requests. His program fixes potholes, alley repairs, and graffiti on DDOT structures. His group also performs the initial investigation to see if an alley needs to be re-done. Big projects are then referred to a different department, known as "Asset Management," which does 95% of the construction projects for DDOT. He shared a list of projects for Ward One for the fiscal year.

A number of neighbors brought up specific repair issues in the area. Many had already reported urgent repair needs to 311 and had not received a response. A neighbor pointed out that only about 5 repair projects in Park View were included in the schedule for this fiscal year.

The meeting adjourned 8:00pm.
